Executive Director Report - Rachel London

- The FFY2023 funding was approved. The Council should receive the final Notice of Award in February.
- The PPR, submitted to ACL each year, is completed and will be submitted by December 30, 2022.
- The Council increased its communications impact. . The stats are as follows:
 - ➤ 63,915 people reached through social media, the website, and email. 40,000 more than last year.
 - ➤ 1,350 copies of the ABLE guide provided.

Public Policy Platform - Rachel London

- The Public Policy Platform was provided for the Council's review. It is on the Council's website and will be sent to all 188 Maryland legislators.
- The End of Life Act may be reintroduced in the 2023 General Assembly. The Council reviewed the End of Life Act for individuals with Developmental
- Disabilities in 2020, and the Council did not take a position on the Bill. Council members agreed to submit a letter of information if the bill is reintroduced.
